WEEKLY REPORT ON THE TREASURY SHARES BUY-BACK PLAN OF DIASORIN S.P.A.

With reference to the treasury shares buy-back plan, DiaSorin S.p.A. hereby announces that, during the period from May 23rd to May 27th, 2016, it purchased no. 67.100 treasury shares for a total consideration of Euro 3,579,935.15, upon authorization of the Shareholders' Meeting on April 28th, 2016, already disclosed pursuant to Art. 144-bis of Consob Regulation no. 11971/1999.
